### 1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

### 2.0 FACTS:

- 2.1 Sh. Sonu had submitted RTI application no. AAIMU/R/T/24/00209 dated 27.09.2024 to PIO, seeking information regarding 'Details for each Senior Assistant Electronics selected in Western Region against Advertisement no. DR-05/12/2018/WR.'
- 2.2 PIO, WR vide letter no. 52042/आरटीआय/केस-418/2024(एम)/431 dated 30/04.11.2024 provided information to the applicant.
- 2.3 The Appellant filed first Appeal no. AAIMU/A/E/24/00048 dated 04.11.2024 before the First Appellate Authority, AAI, RHQ WR, Mumbai.

### 3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

1. Please provide the Emp. ID, Name, Designation, Posting Station, Basic Pay on Joining, and Date of 1st Increment for all Senior Assistant Electronics selected in Western Region Against Advertisement No. DR-05/12/2018/WR.

2. Please provide the Date of Annual Increment and the Percentage of Annual Increment for all Senior Assistant Electronics selected in Western Region Against Advertisement No. DR-05/12/2018/WR.

3. Please provide the circular related to counting the training period for the purpose of the annual increment for Senior Assistant Electronics selected in Western Region Against Advertisement No.DR-05/12/2018/WR.

4. Please provide the appointment letter with terms & conditions and the increment order for each Senior Assistant Electronics selected in Western Region Against Advertisement No.DR-05/12/2018/WR.

3.2 **FINDINGS:**

From the records produced it is observed that PIO, WR vide letter no. 52042/आरटीआय-केस/418/2024/(एम)431 dated 30/04.11.2024 provided information to the applicant. On the same day i.e. on 04.11.2024 the appellant filed first appeal stating that "There is no reply received by appellant as on date 04.11.2024." In this regard it is seen that above mentioned supply of information letter dated 30/04.11.2024 & appeal dated 04.11.2024 appears to be crossed in transit. Further, it has also been intimated by PIO, WR that the above mentioned letter no. 52042/आरटीआय-केस/418/2024/(एम)431 dated 30/04.11.2024 has been uploaded on AAI website. The applicant is advised to refer the same in the AAI website. Since the PIO, WR has taken the requisite action in terms of RTI Act, therefore no directions is required in the matter.

3.3 **ORDER:**

With the above observations, the Appeal AAIMU/A/E/24/00048 dated 04.11.2024 hereby stands disposed off.
