### **1.0 PREAMBLE**

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

### **2.0 FACTS:**

- 2.1 Md. Ahsaan had submitted RTI application dated 30.09.2024 to PIO, Juhu Airport regarding ' Construction of Hotel/ Restaurants/Bars/Pub, construction work of G + 1 over 5 Gaalas unit, carried out at inside the property of Airports Authority of India, Juhu Airport, Pawan Hans, Vile Parle West.
- 2.2 The Appellant filed first Appeal dated 22.11.2024 (Received on 25.12.2024) before First Appellate Authority, AAI, RHQ WR, Mumbai.

### **3.0 FINDINGS & ORDER :**

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has sought information regarding ongoing construction of Hotel/ Restaurants/Bars/Pub, construction work of G + 1 over 5 Gaalas unit, carried out at inside the property of Airports Authority of India, Juhu Airport, Pawan Hans, Vile Parle West.

### **3.2 FINDINGS:**

From the records produced it is seen that applicant Md. Ahsaan had filed RTI application to PIO, Juhu Airport for seeking information regarding


construction of Hotel/ Restaurants/Bars/Pub, construction work of G + 1 over 5 Gaalas unit, carried out at inside the property of Airports Authority of India, Juhu Airport, Pawan Hans, Vile Parle West. The applicant has sought certified copies of complete file papers of the said structures related to permission or NOC granted by AAI.

PIO, Juhu Airport vide letter no. भा. वि. प्रा./जुहू/आर टी आय/2024-25/22/177 dated 30.10.2024 informed applicant that As the information sought would result in disclosure of commercial confidence and it would harm competitive position of third party , hence disclosure of such information is exempted under Section 8 (1) (d) of RTI Act.

In this regard it is seen that applicant is seeking information pertaining to other agencies and tender related documents, which contains various commercial confidence as well as personal information of a third party, disclosure of this information would harm the competitive position of a third party and therefore the sought information is exempted under section 8 (1) (d) of RTI Act.

### **3.3 ORDER:**

With the above observations, the Appeal dated 22.11.2024 (received on 25.11.2024) of Md. Ahsaan hereby stands disposed off.
