FACTS :>

The Applicant has submitted an on-line RTI application vide Reg. No. **AAOIN/R/E/26/00256 dtd. 24/02/2026** under RTI Act 2005 to PIO, Airports Authority of India, CHQ, New Delhi.

FINDINGS :->

After perusing the material placed on record in respect of the information sought by the appellant in his RTI Appeal No. **AAIGU/A/E/26/00008** dtd. **24/03/2026**, it is observed that the Jt.GM(HR)/PIO, RHQ-NER has replied the information to the applicant vide letter no. *AAI/NER/HR/MIS/RTI/ACT-18/39* dated 12-03-2026 is correct.

In view of above, instant First Appeal of **Shri N K Sharma** vide Appeal No. **AAIGU/A/E/26/00008** dtd. **24/03/2026** is **disposed off**.

However, the Appellant **Shri N K Sharma**, if wishes so, may like to file an Appeal against this Order before the Hon'ble Central Information Commission, Room No. 305, 2nd Floor, '6' Wing, August Kranti Bhavan, Bhikaji Cama Place, New Delhi – 110 066 within the statutory time period.
