Sub:- First Appeal under Section 19(1) of the RTI Act, 2005 regarding non-satisfactory response to RTI application

Respected Sir,

I am submitting this appeal under Section 19(1) of the Right to Information Act, 2005, against the unsatisfactory and incomplete response provided by the Public Information Officer (PIO) in reply to my RTI application dated 03.06.2025.

A. Background of My RTI Request:

In my RTI, I asked for a detailed calculation sheet showing how my additional payments were calculated under the contract with M/s Xeam Ventures Pvt. Ltd.

Specifically, I had requested information about:

- (i) The percentage used for 10% to 30% increment and
- (ii) The 2% annual increment on gross wages.

B. Grounds for Appeal:

The reply from the PIO only provided general month-wise payment figures. It did not include:

- (i) Any breakup of the payment.
- (ii) The formula / percentage used to calculate the increment.
- (iii) Step-by-step calculations for each month.

Further, there appear to be discrepancies in the information provided. Namely:

The amount shown for July 2020 is Rs 3517, which is more than the figures for subsequent full months (from August 2020 to July 2021).

As acknowledged in the reply, my joining date was 07.07.2020. Thus, July 2020 should reflect a partial month and not a figure in excess of full working months.

These discrepancies raise serious doubts about the accuracy and completeness of the information provided.

C. Relief Sought:

In light of the above, I request the First Appellate Authority to direct the PIO to furnish a detailed and itemized calculation sheet, month-wise, clearly showing:

- (i) Breakup of amount.
- (ii) The parameter wise percentage used for calculating the 10% to 30% increment.
- (iii) The gross wage considered for applying the 2% annual increment.
- (iv) The exact monthly calculations, step-by-step with specific values for basic wage increment
- (v) Any deductions or adjustments applied during the relevant period.

Conclusion:

The RTI Act aims to promote transparency and accountability. The response provided so far defeats this purpose and may suggest withholding or misrepresentation of material information.

I therefore request your kind intervention for a fair, complete, and prompt resolution of this matter.



B. Grounds for Appeal:

The reply from PIO only provided general month-wise payment figures. It did not include:

Conclusion:

I therefore request your kind intervention for a fair, complete, and prompt resolution of this matter.
