PREAMBLE :->

- This Order is made under Section 19 of RTI Act, 2005.

- The Appeal may be filed within 90 days from the date on which the Order is made or is actually received.

FACTS :->

The Applicant has submitted an on-line RTI application vide Reg. No. AAIGU/R/E/25/00008 dtd. 17/03/2025 under RTI Act 2005 to PIO, Airports Authority of India, North Eastern Region, Guwahati containing the following query:-

With respect to below RTI reply, please provide total JE, AM, and Manager of ATM Department who have or will complete their tenure by June 2025”.


FINDINGS :->

After perusing the material placed on record in respect of the information sought by the appellant in his RTI Appeal No. **AAIGU/A/E/25/00005** Dated **11/04/2025**, it is observed that the General Manager (HR)/PIO, RHQ-NER has replied the information to the applicant vide letter no. AAI/NER/HR/RTIACT/ Dated 11/04/2025 is correct.

In view of above, instant First Appeal of **Shri Nandan Kanan** vide Appeal No. **AAIGU/A/E/25/00005** Dated **11/04/2025** stands **disposed off**.
