### FACTS :->

The Applicant has submitted an on line RTI application vide regd No **AAIGU/R/E/26/00002 dt. 04/01/2026** under RTI Act 2005 to PIO, Airports Authority of India, North Eastern Region, Guwahati containing the following query:

The Jt.GM(HR)/PIO, RHQ, NER has replied to the above query through RTI portal vide letter No. AAI/NER/HR/MIS/RTI/ACT-18/25 dated 22/01/2026 as under.

*“Refused access to Information Requested*

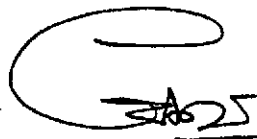

**FINDINGS :->**

After perusing the material placed on record in respect of the information sought by the appellant in his RTI Appeal No. **AAIGU/A/E/26/00003** Dated **23/01/2026**, it is observed that the Jt.GM(HR)/PIO has replied the information to the applicant through RTI portal vide letter No AAI/NER/HR/MIS/RTI/ACT-18/25 dated 22/01/2026 is correct.

In view of above, instant First Appeal of **Shri Niraj Yadav** vide Appeal No. **AAIGU/A/E/26/00003** dtd. **23/01/2026** stands **disposed off**.

However, the Appellant **Shri Niraj Yadav**, if wishes so, may like to file an Appeal against this Order before the Hon'ble Central Information Commission, Room No. 305, 2<sup>nd</sup> Floor, '6' Wing, August Kranti Bhavan, Bhikaji Cama Place, New Delhi – 110 066 within the statutory time period.
