FACTS :->

The Airport Director, Lengpui had not provided the reply to the applicant within time limit.

The present appeal was preferred by the appellant vide RTI Appeal Reg. No. **AAIGU/A/E/26/00004** dtd. **08/02/2026** on the grounds that –

FINDINGS :->

After perusing the material placed on record in respect of the information sought by the appellant in his RTI Appeal No. **AAIGU/A/E/26/00004 Dated 08/02/2026**, it is observed that the Airport Director, Lengpui had not provided the reply to the applicant within time limit.

In response of the appeal No **AAIGU/A/E/26/00004 Dated 08/02/2026** it is informed that the requisite information has now been provided by CPIO & In-charge, Lengpui Airport on 16.02.2026 through RTI portal. The screenshot is attached as Annexure - I herewith for your ready reference.

In view of above, instant First Appeal of **Shri Suneel** vide Appeal No. **AAIGU/A/E/26/00004** dtd. **08/02/2026** stands **disposed off**.
