### PREAMBLE :>

This Order is made under Section 19 of RTI Act, 2005.

An Appeal against this Order, if so wished by the appellant, lies with the Central Information Commission, Room No.305, 2<sup>nd</sup> Floor, 'B' Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066.

The Appeal may be filed within 90 days from the date on which the Order is made or is actually received.

### FACTS :>

The Applicant has submitted an on-line RTI application vide Reg. No. AAOIN/R/E/26/00155 dtd. 05/02/2026 under RTI Act 2005 to PIO, Airports Authority of India, CHQ, New Delhi.

*"The pdf attached in the rti reply is blank and contains no information regarding my rti application. It is therefore again request to provide the information required and asked in the rti filed earlier.*

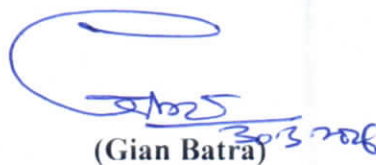
**FINDINGS :->**
