For Point 1, instead of providing certified copies of rules, circulars and office orders as requested, the PIO has merely referred to the AAI website. As per RTI Act, specific documents are required to be provided. A generic website reference is not a valid reply. For Point 3, the PIO has not clearly stated whether a uniform policy exists across India. The query required a clear Yes or No response along with supporting documents. The reply is evasive and incomplete. For Point 4, the PIO has incorrectly stated that the information sought is not specific. The query clearly asked for designation-wise and region-wise details of conveyance loan (2 wheeler/4 wheeler) without personal identifiers. Hence denial on this ground is unjustified. It is requested that the First Appellate Authority may kindly direct the PIO to provide complete and point-wise information, including certified copies of relevant rules, clear clarification regarding uniform policy, and designation-wise region-wise data of conveyance loans.

FACTS :->

The Applicant has submitted an on-line RTI application vide Reg. No. **AAOIN/R/E/26/00556 dtd. 16/04/2026** under RTI Act 2005 to PIO, Airports Authority of India, CHQ, New Delhi.

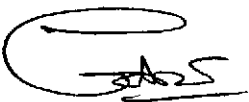

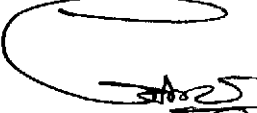


FINDINGS :->

After perusing the material placed on record in respect of the information sought by the appellant in his RTI Appeal No. **AAIGU/A/E/26/00010** dtd. **28/04/2026**, it is observed that the Jt.GM(HR)/PIO, RHQ-NER has replied the information to the applicant vide letter no. **AAI/NER/HR/MIS/RTI/ACT-18/47** dated 28/04/2026 is correct.

In view of above, instant First Appeal of **Shri Sagar Kumar** vide Appeal No. **AAIGU/A/E/26/00010** dtd. **28/04/2026** is disposed off.

However, the Appellant **Shri Sagar Kumar**, if wishes so, may like to file an Appeal against this Order before the Hon'ble Central Information Commission, Room No. 305, 2nd Floor, '6' Wing, August Kranti Bhavan, Bhikaji Cama Place, New Delhi – 110 066 within the statutory time period.
