1. **PREAMBLE**

- i) This order is made under Section 19 of RTI Act 2005.
- ii) An appeal under this order lies with Chief Information Commissioner, 2nd floor, Club Building, Old JNU Campus, New Delhi – 110067.
- iii) The appeal if any may be filed within 90 days from the date on which this order has been made or is actually received.

2. **FACTS**

- 1) Sh. Sunity Kumar Ray had made an online RTI request to the PIO-ER, Airports Authority of India, Kolkata under registration no. AAIKO/R/2017/80028 dated 28.06.2017 for furnishing the following information:

- 2) On receipt of the RTI application from Sh. Sunity Kumar Ray, the PIO/ER had sought the information from the GM (HR), ER as the custodian of information.
- 3) The GM (HR) furnished the required information sought by the applicant vide letter no. AAI/ER/HR/RTI/2017/391-392 dt. 19/07/2017 directly to the applicant.

- 4) However, the applicant Sh. Sunity Kumar Ray not being satisfied with the reply given by GM(HR),ER has made an appeal before the First Appellate Authority i.e. The Regional Executive Director (ER), NSCBI Airport, Kolkata-700052 vide his RTI Appeal Reg. No.AAIKO/A/2017/60005 dated 03/08/2017 which was received in the office on 16/08/2017.
- 5) The First Appellate Authority could not make out exactly what is requested by the appellant. As such, the Appellate Authority through O/o the Airport Director, Bhubaneswar sought a clarification in this regard.
- 6) The Appellant furnished the appropriate details pertaining to his RTI appeal dt. 03-08-2017 vide file no. E-52 dt. 22-09-2017 as appended below:
  - i) Current status of my appeal dated 07-03-2017.
  - ii) The complete file noting on my appeal dated 07-03-2017 at RHQ-ER.


### **3. FINDINGS/ORDER**



PUC letter no. AAI/BA/L-24(Misc)/1908, dated 23/03/2017 (Flag 'A') and a reminder letter vide no. AAI/BA/HR/PT/3184, dated 15/05/2017 (Flag 'B') received from APD, Bhubaneswar regarding the reimbursement of legal expenses and grant of special leave i. r. o. Shri S. K. Ray, Asstt. General Manager (ATC).

The CHQ vide letter no. A25013/01/2014-EA, dated 15/05/2015 in response to Bhubaneswar letter no. AAI/BA/L-24(Misc)/1304-05, dated 11/02/2015 has informed that the request of Shri S. K. Ray was considered by the legal department and the same cannot be agreed to as criminal case is lodged against an individual concerned and AAI in its corporate capacity cannot be a party to the criminal proceedings.

Shri Ray has again requested to forward his application to CHQ (addressed to Chairman). On the plea <sup>that</sup> the Honorable court of SDJM, Bhubaneswar vide <sup>order</sup> dated 11/02/2017 has closed the case against him due to non-acceptance of summon and non-acceptance of the complainant in the court.

This office letter no. AAI/ANS(HR)/ER/Court Case/2015, dated 05/01/2017, <sup>(Flag-D) was forwarded to CHQ</sup> but CHQ's communication is still awaited.
