

2. In this regard the reply / information of HR Department is given as under :-

1	<p>The seniority list of western region was released on 02/11/2022, reference number - AAI/Regional Headquarters/W Region/ Human Resource/Estt-4/Fire/Priority List/2022/22, in which some error was found which needs to be rectified The department was informed by the union that there is an error in this list but it has not been resolved yet.</p> <p>Sir this list had the following error –</p> <p>Note :- In June 2020, 111 candidates joined the Fire Department, whose training was completed from 09/09/2019 to 03/01/2020 in FTC DELHI and FSTC KOLKATA, in which out of 119 candidates, 111 candidates had participated, after that the department released waiting list in which 8 candidates whose (seniority list Sr.No 115.116.117.118.133.160.163.164) were called to FTC DELHI for training whose training was due from 03/02/2020 to Covid Due to be completed in 2021. Those who had joined the Fire Department in September-2021, have now been given a hair above joining in 2020 in the seniority list. PROMOTION TRAINING STARTED AT FSTC KOLKATA FROM 01/05/2023 TO ARC1 WHOSE REFERENCE NO :- AFS/RFO/38 WHICH HAVE ROLL NO 10, 11, 12 &amp; 13 WHO JOIN SEP -OCT - 2021 AND JOIN IN JUNE - 2020 Those who joined were not called. Those who joined in June-2020 were not called, those who joined in SEP-OCT-2021 were called whereas there is a difference of about 18 months between these two joinings. Please solve our problem and I request you to give me complete information about how those 8 people were placed on top of the priority list and on what basis they were sent to the first training.</p> <p>Note- Sir, everyone date of joining is mentioned in the seniority list, which shows which candidate joined when.</p>	<p>The information sought by the applicant does not qualify under Section 2(f) of the RTI Act 2005.</p>
