

Sub: - Compliance Report of Order dated 05.08.2025 of Hon'ble Madurai Bench of Madras High Court in WP (MD) 21339/2025 in the case of Shri R Veeraswamy, GM(Fin.) -reg.

Sir,

Please refer to your representation dated 12.08.2025 addressed to Chairman AAI wherein a copy of the order dated 05.08.2025 passed by Hon'ble Madurai Bench of Madras High Court order in WP (MD) 21339/2025 has been forwarded to this office for compliance of the order of the Hon'ble Court.

2. It is informed that in compliance of the Hon'ble Madurai Bench of Madras High Court order dated 05.08.2025, your representation dated 31.07.2024 has been examined in detail by the Airports Authority of India and it is stated that in Airports Authority of India, the AAI Employees Defined Contribution Scheme (EDCPS) was introduced vide letter dated 07.06.2018. The Scheme was effective w.e.f. 01.01.2007. It was applicable to all regular employees including Board Level on the roll of AAI as on 01.01.2007.

3. So far as issue related to disbursement of salary paid to you consequent upon revision of pay scales in Airports Authority of India and details of arrears paid to you towards EDCPS at various stations of posting is concerned, it is informed that the EDCPS Preliminary Corpus Statement and the salary slips have been verified with the relevant records. The discrepancy of the EDCP contributions for the month of September 2009, and "Contribution on wage revision arrear 2007," were observed during the processing of your application. The contribution amount of Rs. 39,715/- on this account was considered and incorporated in the SBS Card F.Y 2020-2021. Your annuity application was finalized after incorporating this adjustment and the same was forwarded to HDFC in February 2021 for issue of Annuity Certificate.

4. So far as implementation of Hon'ble High Court of Calcutta order dated 22.05.2024 is concerned, it is informed that the Hon'ble High Court of Calcutta vide order dated 22.05.2024 in the case of Shri Gautam Mukherjee and others petitioners has directed the AAI to pay interest from date of superannuation of the petitioners to the date the contribution is transferred to EDCP trust. In this connection, it is submitted that the Hon'ble High Court Calcutta order dated 22.05.2024 was implemented only in the case of petitioners and not for other employees of the Airports Authority of India.


