Madam,

Reference is invited to your RTI application bearing Registration No. AAOIN/R/E/25/01869 dated 29/11/2025 received in this office in 25.12.2025 seeking information under the Act.

2. In this connection, reply in respect of point raised is furnished as under: -

Sr. No.	Query	Reply
i	Reference reply dated 29.04.2025 RTI application registration number MOCV/R/ E /25/ 000121 intimating that differential gratuity has been worked out to Rupees 3,31,913/-. However, I have not yet received the payment. Please intimate reasons for delay in payment of differential.	The case for payment of difference of Gratuity i.r.o Smt. Veena Dhananjay Dhapre, Ex. Sr. Supdt. (Tele) has been received by SSC, CHQ from Region/Airport and has been complied and file has been submitted for perusal and approval of the Competent Authority. It has been decided by the Competent Authority to place the matter before PAB. The decision on the same is still awaited.
ii	As per orders issued by DOPPW the interest is payment on delayed payment of gratuity. Please also intimate amount of interest payment of Gratuity.	As per minutes of meeting held on 06.03.2019 at New Delhi under the Chairmanship of Sh. Arun Kumar, AS & FA, MoCA to review the pending issues relating to payment of Government pensionary benefits to the employees transferred en-masse from erstwhile Civil Aviation Department (CAD) point 06 (ix) No. interest shall be charged on the amount recovered from the pensioners as no interest is payable on the arrears PF pension and amount payable to the pensioners. The Government is also not charging any interest on the Capitalized Value paid by AAI.

iii	Please also intimate arrears of pension payable to me from 01 August 2017 to 29 February 2020.	With respect to payment of Pension Arrears, it is informed that the decision is awaited from the Ministry in r/o cases where the employees have drawn both Government Pension and EPFO Pension. As and when decision is received from the Ministry AAI will take appropriate action.
iv	Please also intimate the status of revision of pension due to revision of pay.	With respect to revision of pension, it is informed that there is no provision of revision of pension on IDA Pattern, however AAI is examining the matter as per directions of MOCA.

3. If you are not satisfied with the information provided, an appeal can be preferred within 30 days of the receipt of this letter before the First Appellate Authority ED (Admin), AAI Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003.
