1	Details of tenders floated in and around IGI Airport in which DIAL/GMR Group has participated.	An Operation, Management & Development Agreement (OMDA) dated 04.04.2006 has been executed between Airports Authority of India (AAI) and Delhi International Airport Limited (DIAL), the JVC, whereby AAI has granted the exclusive right and authority to the JVC to undertake some of the functions of the AAI, being the functions of operation, maintenance, development, design, construction, upgradation, modernization, finance and management of the IGI Airport, New Delhi (the "Airport"), and to perform services and activities constituting Aeronautical Services, and Non-Aeronautical Services (but excluding Reserved Activities) at the Airport.
2	Whether DIAL/GMR Group has obtained any permission or approval from AAI for participating in such tenders floated in and around IGI Airport.	The information sought pertains to or closely related to DIAL and concessionaire at Delhi Airport, which is a 3rd party. Hence, the RTI request has been transferred to the Chief Executive Officer (CEO) of Delhi International Airport Limited ("DIAL") with a request to provide the requisite information to the applicant directly under intimation to this Office.

In case, the applicant is not satisfied with the reply, he/she may file an appeal to the Mr. L Kuppulingam, Executive Director (PPP/JVC), First Appellate Authority, Airports Authority of India (AAI), Joint Venture Cell, C – Block, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003, under section 19(1) of the RTI Act within the time limit specified in the RTI Act.
