2	Details of Revenue share, concession fee, or any financial component received by AAI from parking operations at IGI Airport during the last five financial years.	It is stated that AAI has granted some of its functions of operation, maintenance, development, design, construction, up-gradation, modernisation, finance and management of IGI Airport, New Delhi to the JVC (DIAL) and at all times keep in good repair and operating condition the Airport and to perform services and activities constituting Aeronautical Services and Non Aeronautical Services at the Airport. Accordingly an Operation, Management and Development Agreement (OMDA) dated 04.04.2006 was signed between AAI and DIAL, The copy of the said agreement (OMDA) is available on the website of AAI and the link is given below: https://www.aai.aero/sites/default/files/rtidir/OMDA_DIAL.pdf AAI is getting 45.99% of gross revenue towards Annual Fee/Monthly Annual Fee from DIAL, as per provisions of OMDA.
