

Reference is made to the RTI application No.AAICH/R/E/23/00102 dated 10.07.2023 in respect of Shri.Harsha C, Kerala seeking the information under RTI Act, 2005.

1	As per the advertisement (Ref.1) there were 88 vacancies for the UR category. But the Provisional selection list of candidates for training is having only 75 UR candidates. Why balance 13 vacancies left unfilled?	13 vacancies reserved for ESM category. 13 vacancies will be filled up by ESM category only since other categories, all the vacancies have been filled.
2	If it is due to the lack of qualified ESM candidates. (i) Are there any provision to keep those 13 positions vacant without filling them with eligible candidates from UR category? (ii) AAI did not provide a separate category for Ex-Servicemen, instead, Ex-servicemen are horizontally adjusted against respective categories (UR/SC/ST/OBC). So Provide any supporting documents/govt. order to keep that positions vacant. (ii) From which list the vacancy is going to be filled? (iii) Do you have any unpublished supplementary list for this? Provide a copy.	The information sought is a nature of seeking explanation / reason from the Public Authority and does not qualify under Section 2(f) of the RTI Act, 2005.
5	Why AAI did not publish the list of candidates who qualified the second stage of selection (PET) before publishing the Provisional Selection list for training? Please provide the list of candidates (with their roll number, Physical test mark, and category) who have qualified the Stage II of selection (PET).	The information sought is related to a third party, the disclosure of which has no relationship to any public interest. The disclosure of such information is exempted under Section 8(1)(j).
