


Reference is invited to meeting held on 27/04/2022 under the Chairmanship of Joint Secretary, Ministry of Labour and Employment (MoLE) regarding the matter of stoppage of EPF Pension in respect of CAD absorbees who had rendered less than 10 years service in CAD.

2. In this connection, reference may also be made to this office letter dated 26/08/2022 (Copy enclosed) wherein the requisite informations as sought by MoCA was provided by AAI for onwards submission to M/o Labour and Employment (MoLE). It is, also informed that AAI has been following up the matter with EPFO time and again and recently a DO letter (Copy enclosed) under the signature of Chairman, AAI addressed to CPFC, EPFO, has been issued. However, no response on the issue received from EPFO till date.

3. Due to non-resolution of the above issue, dual pension is being regularly disbursed to 645 superannuated employees, out of 2065 Govt. Pension optees. Further, numerous greivances from different quarters are being received regarding non-processing of their pension and arrear cases in r.o those employees who have received EPF Pension.

4. In view of the above, it is requested that MoCA may take up the matter again with Ministry of Labour for stoppage of EPF Pension in respect of 645 employees drawing Govt. Pension.
