

1	<p>I have applied for the post of Sr. Asst. (Accounts) against the Advt. No.SR012022. I topped the exam with 79 marks and got selected for document verification process in Chennai on 23.02.2023.</p> <p>AAI SR has recently released a list of candidates selected for the same post. There is a total vacancy of 13 candidates and only 10 candidates have been selected, 3 out of 7 vacancies in the UR category has not been filled. I belong to UR category and all candidate selected are below me in ranking.</p> <p>I have the following queries:</p> <ol style="list-style-type: none">1. What is the status of my candidature and why has it been kept pending?2. Is there an audit for ensuring that the selection process is kept transparent?3. If answer is YES to query 2 above, then when will it be conducted and when will the audit report be published?	<p>The eligibility criteria for Post of Sr. Asst. (Accounts) as notified is graduates preferably B.Com with computer training course of 3 to 6 months and 2 years relevant experience in the concerned discipline.</p> <p>Your candidature was not considered for the post of Senior Assistant (Accounts), since you have not uploaded in online the proof of having computer training course of 03 to 06 months and also not submitted the proof during document verification, as advertised for the post.</p> <p>In the instant case, it is in the form of queries and the same does not qualify under RTI Act, 2005. Further, right of the applicant does not extend to question nor seek reasons from the Public Authority.</p>
