

I have checked Airports Authority of India Act, 1994, AAI R&P Regulations, 2020, General Clauses, 1897, Nowhere the term Experience is defined in such a way that Experience should be Post qualification.</p> <p>Taking Decision on the Basis of Point which is not there in the Notification & Relevant acts & Regulations is Valid? Ethical? Justified? Is it not Your Responsibility to issue the notification in such a way that Multiple Interpretations are not possible?</p> <p>In my application it is clearly mentioned that I have passed my graduation in June 2021 from IGNOU & I have experience starting from Jan 2020. If experience should be post qualification then why AAI software has accepted my application? Why AAI failed to perform a basic due Diligence once the application window is closed by exporting the Data to Excel even after collecting Rs.1090 towards exam fee? How are you going to compensate for the loss of 6 months of valuable time in my life?

My graduation is a MOU between ICAI & IGNOU to provide B.Com Degree to CA Inter Passed students by writing just 6 papers in one sitting & credit transfer of the subject studies in CA Inter & there is no requirement to attend any classes, we just have to write term end exams (TEE), It is not a regular 3 years degree. I have passed CA Inter in May 2019 & after that I have started working on the Basis of CA Inter & I have enrolled for the degree from IGNOU through online in Jan 2020 & appeared for DEC 2020 TEE. And they have given me Degree in June 2021 Convocation.

I have not worked while I was studying, I have studied in Distance mode while I was working.

According to the Chartered Accountants Act, 1949 & CA Regulations, 1988, No paper is allowed as exemption to Graduates, if they want to join in CA-Inter. But for us the majority of subjects in Graduation.

Based on the above point, I request AAI to decide which is Higher Qualification.

Corporate Companies consider CA Inter is more than B.Com.

When I was working with B.Ajai Kumar & Company, I have worked on accounting, Income Tax, GST, Internal Audits, Statutory Audits, Branch Audits, Revenue Audits, Concurrent Audits. I have also appeared before GST Dept., & Income Tax Dept., on behalf of clients in responses to the notices.
