Option for Pension / Superannuation Benefits
under Government Pension Rules

I, _____, Son/ Daughter/ Wife of _____,
served as _____ in the Civil Aviation Department, Government of India,
prior to my transfer and subsequent absorption in the National Airports Authority
(now Airports Authority of India), in exercise of the extant provisions of the Central
Government Pension Rules, as clarified by the Department of Pension and
Pensioners' Welfare OM No.4/18/87-P&PW(D) dated 05.07.1989, do hereby
exercise my option as under:

- (a) I hereby opt to be governed by the Pensionary benefits of the Central
Government that may be due to me at the time of my superannuation /
retirement, in respect of the combined service rendered by me in the
Government and the National Airports Authority / Airports Authority of
India.

I understand that:

- i) I will not be eligible for the CPF & EPFO pension or any other
superannuation benefit scheme of AAI.
- ii) I will not be eligible for the credit afforded to my CPF Account as
Employer's Contribution and interest accrued thereon.
- iii) Amount already received by me against the Gratuity and EPFO
Pension will be adjusted against the amount of Gratuity & Government
Pension payable under CCS (Pension) Rules of Government of India.
Difference will be payable / recoverable in cash.

I further undertake that I will refund:

- i) Whatever terminal benefits received by me from the Government at the
time of my transfer / absorption to NAA/AAI, together with interest at
applicable rates.
- ii) Whatever amount, withdrawn by me from Employer's Contribution of
CPF, along with interest thereon at applicable rates.

I hereby authorize to recover all the above dues from the arrears of pension /
commutation of pension payable to me and I further undertake that I will
deposit the difference, if any, due from me.

- (b) I opt to be governed by NAA CPF Regulation Scheme / Superannuation
benefit schemes of AAI.
