**1.0 Preamble:**


- 1.1 This order is made under Section-19 of the Right to Information Act 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, August Kranti Bhavan, Bhikaji Cama Place, New Delhi – 110 066.
- 1.3 The appeal may be filed within 90 days from the date on which this order should have been made or is actually received.

**2.0 Brief facts of the Appeal:**

- 2.1 Sh. Nishant Thard, Gandhi Park Road, Pin Code : 786125, Assam made an on-line RTI Application No.DIRKA/R/E/23/00003 dated 13.02.2023, received by AAI, Kolkata Airport on 07.11.2022 seeking following information :-
- Please provide Seat No. and PNR No. passenger name Nikunj Thard and Ankita Thard travelling by Indigo flight on 02.09.2021 from Kolkata to Dibrugarh.
  - Please provide Seat no. and PNR No. passenger name Nikunj Thard and Ankita Thard traveling by Indigo flight on 04.09.2021 from Dibrugarh to Kolkata at around 10.00 AM flight.
- 2.2 Since the queries raised by the Applicant in the RTI Application does not pertain to AAI, NSCBI Airport, Kolkata the same was forwarded to M/s. Indigo Airlines, Kolkata Airport by the PIO, NSCBI Airport, Kolkata vide e-mail dated 13.02.2022 with a copy of the e-mail marked to the RTI Applicant.

- 3.0 The applicant has now preferred an Appeal to the First Appellate Authority vide online RTI Appeal No. DIRKA/A/E/23/00001 dated 23.02.2023 stating that "without giving my reply my case is closed."
- 4.0 **Findings / Order:**  
The undersigned has perused the RTI Application dated 13.02.2023 filed by the Applicant.
- 4.1 Your RTI date of application was filed on 13.02.2023 and PIO, NSCBI Airport, Kolkata forwarded RTI Application vide e-mail dated 13.02.2022 without any delay on the same day to M/s. Indigo Airlines, Kolkata Airport as the matter does not pertain to AAI, NSCBI Airport, Kolkata with a copy of the aforementioned e-mail marked to the RTI Applicant.
- 4.2 Further, it may be noted that U/s 2(f) of RTI Act, 2005, the PIO is required to give information/document which are available with the organisation. In the instant case, as the said information is not in the possession of AAI, PIO is not liable to provide the information under RTI Act, 2005.
- 4.3 Hence, the contention of the Applicant in the instant Appeal dated 23.02.2023 stating that "without giving my reply my case is closed" is not factually correct.
- 4.4 In view of above, Appellant's appeal dated 23.02.2023 stands disposed off.
