1.0 Preamble:

- 1.1** This order is made under Section-19 of the Right to Information Act 2005.
- 1.2** An appeal against this order lies with Central Information Commissioner, Central Information Commission, August Kranti Bhavan, Bhikaji Cama Place, New Delhi – 110 066.
- 1.3** The appeal may be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 Brief facts of the Appeal:

- 2.1** Sh. Sakil Pal Meena, F-2, Kavyam Apartment, Shiv Officers Colony, Ramanagariya, Jagatpura, Jaipur, Pin : 302017 made RTI application NO.DIRKA/R/T/24/00035 dated 17.04.2026 seeking certain information, which was received by Airports Authority of India, NSCBI Airport, Kolkata on 17.04.2026 on being transferred from AAI, Eastern Region, Kolkata with Reference Number : AAIKO/R/E/26/00055. The query raised vide the aforementioned RTI application and the reply furnished by the CPIO, NSCBI Airport, Kolkata is reproduced hereunder:

<i>Information Sought vide RTI Application No. DIRKA/R/T/26/00026 dated 17.04.2026.</i>	<i>Reply by CPIO, AAI, NSCBI Airport, Kolkata vide letter No. AAC/RTI/2026/37 dated 13.05.2026.</i>
<i>Please provide me the Total number of AAI employee (Executives and Non-Executives) of all Disciplines posted at NSCBI Airport who were granted permissions/NOCs for private/personal foreign visit after their proposed/applied date of departure (Not before their proposed/applied date of departure of private/personal foreign visit, i.e., post-facto approval cases) during the period from 01.01.2025 to till date. The requested information pertains to Number only and no personal record/copies of approvals are being sought. Hence it is not a third information.</i>	<i>No such recorded information is available.</i>

3.0 Having been dissatisfied with the said Reply dated 13.05.2026 of CPIO, AAI, NSCBI Airport, Kolkata, the Applicant/Appellant has now preferred the instant online Appeal to the First Appellate Authority vide No. DIRKA/A/E/26/00026 dated 15/05/2026 on the ground 'Provided Incomplete, Misleading or False Information'.

4.0 **Findings / Order:**

The undersigned has perused the RTI application dated 17.04.2026 filled by the Applicant and reply furnished by the CPIO vide letter dated 13.05.2026. Hence, there is no delay by the CPIO as the same has been furnished within the prescribed time limit of 30 days, as per RTI provisions.

4.1 On perusal of the Appeal of the Applicant/Appellant, it appears that the Applicant/Appellant has sought a specific information related to number of NOCs/Permissions issued after date of departure of foreign visit (i.e. post facto approval/permission) to AAI employees (Executives and Non-Executives) posted at NSCBI Airport, Kolkata during the specific period from 01st January, 2025 to till date.

4.2 In view of the above, the CPIO is directed to explore the possibility of furnishing the information to the Applicant/Appellant within the prescribed time period as per the provisions of RTI Act, 2005 from the date of issuance of this Order.
