Please refer to the following RTI Queries raised by Sh. Bhoopendra, dated 02.04.2025, seeking information under RTI Act 2005 about the details related to MLCP at Chennai Airport.

The reply for the same are furnished below:

Sr No	Query	Information
1.	On 29 March 2025, I entered in Chennai Airport for dropping my relatives at T1. I was charged with 500 INR penalty by Private Agency saying that I have exceeded the time limit of 10 minutes for dropping. They fixed a clamp in my car tyre and cut the slip for unauthorised parking even I was inside the car with my wife and son. Please provide me the images and video of car CH01CB7525 when it was fined by them. Can a car be fined for unauthorize parking if some one is inside the car. Is the traffic controlling agency permitted to put a penalty for exceeding the time limit of 10 minutes of dropping time. I am a serving Air Force personnel. Is any defence personnel is charged for parking or toll at airport while in private car.	1. Please provide me the images and video of car CH01CB7525 when it was fined by them: Image of car is attached. Video recording is denied under RTI Act, 2005 Section 8(1)(g). 2. Can a car be fined for unauthorize parking if some one is inside the car : The entire lanes from airport entry gate to airport exit gate is a no-parking zone. Vehicles are allowed to only pickup and drop passengers at these lanes infront of terminal buildings and are not allowed to park or overstay and a penalty of Rs.500/- shall be invoked as per prevailing norms of AAI for violation. 3. Is the traffic controlling agency permitted to put a penalty for exceeding the time limit of 10 minutes of dropping time: As per the Development Agreement executed between Multi Level Car Parking Developer and AAI at Chennai Airport, the Developer shall be responsible to ensure that no vehicles are parked in the non-parking area of the airport zone. The penalties for contravention of the provisions of AAI management of Airport Regulation 2003 may be imposed by the Developer. 4. I am a serving Air Force personnel. Is any defence personnel is charged for
