Kindly provide the copy of rules, circulars, orders, or notifications under which an entrance fee is being charged from devotees/visitors visiting Santhi Amman Temple located within the airport area..	No specific rules, circulars, orders or notification is issued by AAI related to collection of entrance fee from devotees/visitors of Santhi Amman located within the Airport Area. However, for vehicles entering Airport, parking fees is applicable as per approved tariff. There is no exemption for visitors of Santhi Amman Temple which is located in the airport area.
2.	Please provide the reason for charging money from devotees visiting the temple, even when they are not entering the airport or availing any airport facility.	As above.
3.	Please state since when this fee system was introduced for Santhi Amman Temple visitors and the authority who approved it.	As above.
4.	Please provide the total revenue collected annually (last 3 years) by AAI or any contractor/agency from devotees as entrance fee for Santhi Amman Temple visit.	Details of revenue collected by parking contractors/agency from devotees for Santhi Amman Temple is not available with AAI.
5.	Kindly clarify whether any exemption system / free pass / identity card is available for devotees whose families have been traditional worshippers of the temple. (Kuladeivam/Kulatheivam temple). If yes, please provide a certified copy of such policy/circular.	No exemption/Free pass/Identity card is issued by AAI.
