1.	The total number of airports in India where Udan Yatri Café is operational. Please provide a list of these airports.	Information of all airports is not available at Chennai Airport. At Chennai Airport Udan Yatri Café facility has commenced w.e.f 27.02.2025.
2.	Copies of agreements, contracts between AAI and the operator of Udan Yatri Café at all operational locations.	Licensee for Exclusive Master Concession for F&B has extended the service of Udan Yatri Café through one of their existing outlets.
3.	Details of the tendering process, including copies of advertisements, list of bidders, and final allotment details.	Not applicable.
4.	Duration and terms of the lease or license for the cafes operation.	The License period of Udan Yatri café will co-terminus with existing Master Concessionaire for F&B i.e. upto 27.03.2027.
5.	Guidelines set by AAI regarding pricing of meals, food quality control, and hygiene standards at Udan Yatri Café.	As per contract conditions of Master Concession for F&B facility.
6.	A list of meal items along with their price details at different airport locations.	Items and price details of Chennai Airport are given below: Tea - Rs.10, Coffee - Rs.20, Water - Rs.10, Samosa/Vadai - Rs.20 and Sweet - Rs.20.
7.	Copies of inspection reports conducted by the concerned authority for food quality and hygiene in the last three years.	Udan Yatri café commenced only from 27.02.2025. Quality checks are embedded in the License Agreement of MC in vogue.
