The desired information requires collection, extraction, collation of data and drawing of inference and or/making assumptions or to interpret information. Hence as such is outside the purview of RTI Act 2005. (Refer para 10 of Guide on the RTI Act, 2005 dated 28 th Nov 2013 issued by DoPT)
2.	How many employees are included in the Centralized Office manpower CO,DEO, MTS, OA tender at various airports of AAI.	The query pertains to RHQ-SR as the contract is awarded by RHQ-SR.
3.	What is the provision for regularizing the tender employees serving in AAI for more than 10 to 15 years ?	The query pertains to RHQ-SR as the contract is awarded by RHQ-SR.
4.	What other benefits are given to contract employees apart from minimum wages if their work experience is more than 10 years ?	The query pertains to RHQ-SR as the contract is awarded by RHQ-SR.
5.	AMC, CMC employees serving more than 10 years in AAI will be given equal benefits as Centralized Outsourcing employees, that they will also be included in the Centralized tender.	The query pertains to RHQ-SR as the contract is awarded by RHQ-SR.
6.	Are CL, ML, Coff and other benefits given to the manpower of AMC, CMC like Centralized Outsourcing manpower in AAI.	In the present manpower contract of M/s WCS, CL, ML, C-Off are provided to the contract manpower as per the tender conditions.
