



03.	In what cases, spouse working in PSU and drawing only claiming HRA(not DHRA) a non-eligibility for claiming DHRA for an AAI employee posted at Portblair?	
04.	In which cases, an employee posted at Portblair can claim DHRA for his dependent parents, provided his spouse is working and claiming only HRA?	
05.	Refer attachment (CHQL.L-r No.A.60011/60 /2008-PP/214 dated 18.04.2019.) Point No. 3. Provide details of representation from the officers mentioned in the circular. For whom they claimed DHRA?
