





Subject: Provision of Budget-Friendly Food and Beverage Facility at Airports- Reg.

Madam/Sir,

India's aviation sector is witnessing rapid growth, leading to increased passenger expectations for accessible and affordable facilities at airports. This necessity is further underscored by passenger grievances regarding the lack of budget-friendly options for eatables.

2. In light of the above and to ensure passenger satisfaction, at airports where Master Concessions are not functioning, it is imperative to initiate immediate action under **Para C-2 of CM-2019 (pg. no. 109)** to establish a stop-gap arrangement for providing basic budget-friendly facility for beverages and edible items. This step will not only address passenger concerns but will also contribute to improving ASQ rating.

3. The modalities i.r.o. of budget-friendly facility shall be as follows:

1. Following items are to be made available:

- Tea/Coffee: 150 ml at a price with an upper ceiling of ₹30/-
- Branded bottled/packed water: 500 ml at a price with an upper ceiling of ₹20/-
- Biscuits and Cup Noodles: To be sold at local MRP
- Local Snack Item (2 numbers): At a price with an upper ceiling of ₹100/-

2. Location and Area Guidelines:

- Location: Canopy or Pre-SHA
- Area: 5 sqm

4. Thus, the Competent Authority has directed the Regions (for airports under their control) to ensure compliance of the above-mentioned arrangements. Additionally, post the implementation of stop-gap arrangements, it is also advised to take necessary steps to establish a regular facility providing similar budget-friendly option.

5. An ATR may please be submitted to this office for appraisal of the Competent Authority.
