

1. As per the details available in LM department at Trivandrum, it is once again intimated that the survey sketches of the land comprised in survey Nos.345, 1841, 1838, 1837, 1790/C mentioned as acquired for the Vallakkadavu-Shanghumugham PWD Airport Road in the RTI application submitted by Sri.K. Prasad, are not available in the office of AAI, Trivandrum Airpopt.
2. It may please be noted that part area of land comprised in survey/sub division numbers 1790/C is under the possession and enjoyment of Airports Authority of India for the last many years. Areas in survey/sub division numbers of 1790/C has been entered in the Poramboke register of Pettah village as 'land acquired for Trivandrum Aerodrome' during 1953. But, the land acquisition details of the same are not available in LM department of Trivandrum Airport. It may also be noted that as per copy of Poramboke/Tharisu Register issued by the Village Officer, Pettha it has been noted in the same that the areas comprised in survey/sub division numbers of 1790/C, 1790/C-14, 1790/C-3 etc. acquired for the "Vallakkadavu - Shanghumugham road".
