2	Kindly provide information whether this office has granted recommended or examined any request for permission under Rule ninety one for selling fish chicken or mutton at or around Dabri Mod Market which falls within the ten kilometer radius of the airport.	
3	Has this office conducted any inspection examination or verification process regarding licences or permissions obtained by the allottees of Dabri Mod Market who are allegedly selling fish chicken or mutton If yes kindly provide copies of such examination or inspection reports.	
4	Please confirm whether this office is aware that the allottees at Dabri Mod Fruit and Vegetable Market were originally allotted space exclusively for fruit and vegetable trade and whether selling fish chicken and mutton amounts to misuse of allotment. Kindly provide details of the action taken by this office if an allottee is found to be violating allotment conditions or carrying on a prohibited activity without DGCA permission under Rule ninety one.
