Please refer to the following RTI Queries raised by Shri.Murugadas seeking information under RTI Act 2005 about Car Parking charges levied from cars exceeding free time.

Details regarding information about Car parking at Chennai Airport are as follows:

Sl.No.	Question	Reply
1	Recently from August, 2019 onwards, any four wheeler entering and exiting the Chennai Airport for dropping or pick up of passengers need to compulsory pay .40 rupees upto first 10 minutes. Previously, upto 10 minutes there was no charge. Chennai is the only airport as far I know, charging this fee which is not the case with other airports in India. Kindly I would like to know under RTI, what is the reason for this new charge. Atleast 10 minutes was free before. What are the extra amneties provided by AAI for this additional new charge of 40 rupees. Already the passenger is paying enough	<p>The vehicle parking policy which was formulated by Corporate Headquarters of AAI was implemented at Chennai Airport at International Terminal on 15.07.2019 and Domestic Terminal on 16.07.2019.</p> <p>As per the New policy all the vehicles going to Departure level for dropping the passengers are exempted from paying any fee.</p> <p>At the Arrival level only private vehicles and AAI Licensed car rental operators and cab aggregators are allowed to pick up the passengers without paying any fee.</p> <p>All other yellow board vehicles have to pick up the passengers from the</p>
