1.0 PREAMBLE

- 1.1 This order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 The Appeal against this order lies with the Central Information Commissioner, CIC Bhavan, Baba Gangnath Marg, Munirka, New Delhi-110067
- 1.3 The Appeal may be filed within 90 days from the date of which this order is made or is actually received.

2.0 FACTS

- 2.1 The Appellant, SH.AKSHAY MOHAN KUMAR, PRANAVAM KUNNEVILLA VATTAVILA P O, NEYYATTINKARA, THIRUVANANTHAURAM - 695132, has filed an RTI Request dated 06/08/2024 seeking the following information (Copy enclosed):
 1. What kind of leaves are included in 30 days during probation period for newly joined employee under AAI.
 2. Does COFF (Compensatory OFF) are included in those 30 days.
 3. Does CH (Closed Holiday) are included in those 30 days.
- 2.2 On receipt of the response from DPIO i.e. JGM (HR), the CPIO, Chennai Airport vide letter No.AAM/RTI/GM(Ops)/DIRCA/R/E/24/00064/2024-25 dated 05/09/2024 has provided the reply accordingly. Hence, the RTI application dated 18.08.2024 is hereby disposed off.
- 2.3 Whereas, the Appellant has now made First Appeal dated 16/09/2024 to FAA, AAI, Chennai Airport received on 16.09.2024, requesting for official circular/document supporting the reply from AAI stating that "details not provided".

3.0 OBSERVATIONS OF FAA:

On examination of the Appeal and the response of the CPIO, it is observed:

- 3.1 That the RTI Request has been replied by the CPIO on 05/09/2024 which is within the stipulated time period of 30 days from the date of receipt of the request.

3.2 That the CPIO has provided the information with regard to Query No.1 stating that "30 days EL and 20 days HPL in a calendar year" and query No.2&3 as "No", wherein the sought information has been given within the time limit.

4.1 That the appellant has not requested any proof such as circular / document supporting the reply from AAI in his RTI request dated 18.08.2024. If at all the circular/document required the appellant might request separately through RTI application.

5.0 ORDER

5.1 In view of the above, the RTI reply given by CPIO, AAI Chennai Airport is in order.

5.2 Accordingly, the above appeal of SH.AKSHAY MOHAN KUMAR dated 08/09/2024 is treated as disposed off.
