

Respected Sir,

IT IS observed that number of re-tenders has been surprisingly increased in recent times at Airports Authority of India (AAI), a PSU organization of the Government of India for their various **open e-tenders** of operation and maintenance of electrical and mechanical installations and similar nature of works.

- i. Most of the cases wherein EMD exemptions are allowed.
- ii. Some MSME bidder(s) are not accepting the tender despite becoming L-1 after opening of financial bid and the same practices applying from one station to another stations. Therefore, rates of contenders which is confidential are becoming opens.
- iii. Moreover, failing to execute contracts within the original bid validity and **frequent extensions / re-tenders by AAI** are seems to be against the Public Procurement Procedure of the Government of India, which is also causes a loss of departmental revenue, loss of time and loss of organizational goodwill as well of AAI.

Hence, under RTI Act, 2015 we do desire to seek the following information **for the period of 01/09/2022 to 31/08/2023.**
