This passenger terminal constructed near Arjun Nagar Gate for passengers taking flight from current Civil Enclave, which is inside IAF Kheria Station, is ready since long. We would like to know as under-

1. When it will be open for Passengers? Huge investment has been made in constructing it. Tax payer's money is invested and it is lying un used. On the other hand passengers face lot of problem at the Arjun Nagar gate, where even basic amenities like toilets are not available.
2. Please let us know the reason for the delay in starting the passenger terminal, even after it is constructed?
3. If this constructed Passenger Terminal is not made operational, will it be declared "not useable" and will be demolished? Please confirm.
4. Who approved it and what is the cost of construction?
5. Did Airport Advisory Committee, Agra play any role in getting this made?
6. What was the agreement with IAF? Is there change in the agreement?
