

1	<p>Information regarding slaughter houses/meat shops and fish shops around the airport.</p> <p>You are requested to refer Section 5 (qq) of The Aircraft Act - 1934 and Rule-91 of The Aircraft Rules-1937 which read as under</p> <p>The Aircraft Act-1934 - Section 5(QQ)</p> <p>The prohibition of slaughtering and flaying of animals and depositing rubbish filth and other polluted and obnoxious matter within a radius of ten kilometres from the aerodrome reference point.</p> <p>THE AIRCRAFT RULES 1937 - PART XI Aerodromes - Rule-91</p> <p>Prohibition of slaughtering and flaying of animals, depositing of rubbish and other polluted or obnoxious matter in the vicinity of aerodrome.</p> <p>No person shall slaughter or flay any animal or deposit or drop any rubbish, filth, garbage or any other polluted or obnoxious matter including such material from hotels, meat shops, fish shops and bone-processing mills which attracts or is likely to attract vultures or other birds and animals within a radius of ten kilometers from the aerodrome reference point.</p> <p>Kindly provide the following information regarding Ahmedabad, Delhi and Mumbai airport.</p> <ol style="list-style-type: none"><li>1. Kindly supply copies of list of slaughter houses and meat shops/poultry shops closed during last 2 years.</li><li>2. Kindly supply copies of minutes of the Airfield Environment Management Committee meetings held during last 2 years.</li></ol>	<p>The information sought does not pertain to Joint Venture Cell (JVC), hence is not available with this office.</p> <p>The reply of this RTI already has been given to Sh.
