

Sub : Grant of two additional increments to fire staff

Reference is made to CHRM Circular No.33/2011 dated 20/07/2011 wherein it was clarified that two additional increments may be granted in the pre-revised scale of pay to all those Sr. Assistant(FS), who have been certified to drive CFTs.

2. In this regard, the competent authority has decided that the employees in NE-6 who have been given the benefit of two increments in line with the order under reference shall continue to draw the same benefit and these increments shall get merged on promotion / placement to higher grade or revision of pay scales, whichever is earlier.

3. The fire personnel who were recruited before 01.01.2007 but have been promoted / being promoted to NE-6 on or after 01.01.2007 shall also be eligible for two increments @ Rs.180/- each (pre-revised scale) from the date of their promotion to NE-6, provided they are in possession of HMV license and drive CFTs for 12 hours in a week. The additional increments, shall in their case also, get merged in the event of their further promotion / placement to higher grade with pay fixation or pay revision.

4. Further, new incumbents inducted in fire discipline on or after 01.01.2007 onwards, however, shall not be entitled for grant of these two increments as they are already possessing HMV driving license as part of their duty.

5. In order to keep the driving license valid/operational, these Sr.Assistant(FS) shall drive CFTs for 12 hours per week and the same must be certified by the Fire Station / Station-in-Charge.



2. In accordance with Hqrs. letter No.PERS/MPP/1106/99/2007 dated 31st August, 2007, the employees mentioned at Sl. No. **10, 22, 28, 31, 33, 36 to 46 & 49 to 54 and 56 to 62** who have been **promoted on ad-hoc basis** as per the undertaking submitted by them. They will be required to undergo JFO Course and qualify the same within a period of two years from the date of issue of this order, failing which they will not have any claim over seniority on ad-hoc promotion, in any case whatsoever. The employees mentioned in Sl. No. 89 to 95 were absorbed on lateral movement/ transfer basis. Therefore, benefits arising out due to restructuring, if any, in NAD will also be taken into account.

3. Their pay will be fixed notionally and **actual financial benefit would be applicable from 27.04.2006.**

4. The incumbents so promoted or subsequently placed in the higher scale will have to perform the similar jobs and responsibilities to meet the operational requirement until unless otherwise specified.

5. The above orders are subject to review by the Competent Authority.
