Sir,

This has reference to the RTI Application No.DIRKA/R/T/26/00055 dated 30/07/2026 received by this office on being transferred from AAI CHQ, New Delhi with Reference Number : AAOIN/R/E/26/01182.

The reply to the queries raised under Sl. No.1 to 12, the following is submitted for information as available on record specific to AAI, NSCBI Airport, Kolkata :-

Reply in respect of Point No.1,2,3, 11 & 12 :

- (a) Presently, there is no flight operating as a Schedule or Non-Schedule in the name of "VISTARA" from Kolkata Airport.
- (b) Not a single flight operated from 12th November, 2024 in the name of "VISTARA" from Kolkata Airport.
- (c) The information sought under Sl. No.3, 11 & 12 may please be treated as 'NIL' in respect of Kolkata Airport.

Reply in respect of Point No.4 to 10 :

- (i) M/s. TATA SIA Airlines Limited (Vistara) intimated AAI CHQ, New Delhi regarding its amalgamation with M/s. Air India Limited.
- (ii) Subsequently, AAI CHQ, New Delhi communicated the said development to all Airports, consequent upon the amalgamation of M/s. TATA SIA Airlines Limited (Vistara) with M/s. Air India Limited.
- (iii) Consequent upon the amalgamation, no fresh allotment of office space, ticketing counter or any other commercial space has been made by the Department of Commercial, AAI, NSCBI Airport, Kolkata in the name of VISTARA Airlines/M/s. TATA SIA Airlines Limited after its amalgamation with M/s. Air India Limited.
- (iv) Further, the spaces earlier allotted to M/s. TATA SIA Airlines Limited (VISTARA) have continued to be utilised under the amalgamated entity i.e. M/s. Air India Limited. Accordingly, the billing in respect of such spaces has been raised in the name of M/s. Air India Limited with effect from December, 2024.
- (v) Accordingly, as per the records available with the Department of Commercial, AAI, NSCBI Airport, Kolkata, there is no fresh/independent allotment of commercial space in favour of VISTARA Airlines/M/s. TATA SIA Airlines Limited subsequent to its amalgamation with M/s. Air India Limited, and the billing in respect of the spaces earlier allotted to VISTARA has been made in the name of M/s. Air India Limited w.e.f. December, 2024.
