
Reference may kindly be made to your RTI request dated 18.04.2024, received on 23.04.2024 for providing information under RTI Act, 2005.

The information sought by you and reply thereof is as under:

Sl. #	Information Sought	Reply
1	Are there any parking charges at IGI Airport (Arrivals), if one is going to collect a passenger?	As per Article 2.1.1 of chapter II of Operation, Management, and Development Agreement (OMDA) AAI has granted exclusive right to Delhi International Airport Limited (DIAL) to carry out functions of operation, maintenance, development, design, construction, up-gradation, modernisation, finance and management some of its function, being and to perform services and activities constituting Aeronautical Services, and Non-Aeronautical Services (but excluding Reserved Activities) at the Indira Gandhi International Airport, New Delhi, which has agreed to undertake the same.
2	What is the time stipulation for free pick up of passenger from IGI Airport (Arrivals)?	As per Schedule 6 of OMDA, vehicle parking is one of the Non-Aeronautical Services.
3	If Yes, then how is calculated?	The sought information is neither available nor maintained in Joint Venture Cell of AAI. The information sought pertains to or closely related to functions of Delhi International Airport Limited (DIAL). Hence, the RTI request has been transferred to the Chief Executive Officer (CEO) of Delhi International Airport Limited (DIAL) with a request to provide the requisite information to the applicant directly under intimation to this Office.

In case, the applicant is not satisfied with the reply, he/she may file an appeal to the Sh. L.Kuppulingam, Executive Director (PPP/JVC), First Appellate Authority, Airports Authority of India (AAI), Joint Venture Cell, C – Block, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003, under section 19(1) of the RTI Act within the time limit specified in the RTI Act.
