2	Delhi airport, owned by GMR, group, has won an arbitration against the airport authority of India (AAI) of Rupees 2300 CR. Over revenue sharing during the covid-19 pandemic. The airport, which pays 45.99% of its annual revenue as concession fees.	No information has been sought.
3	Media reports shared the full coverage of the said arbitration award kindly refer the report attached with this application below.	No information has been sought.
4	Applicant wants to know the steps taken by AAI to challenge the award of 2300 Crore as award involves public money and being a tax payer of the country and in public domain applicant seeking information that audit report has been executed or not by AAI against DIAL loss of revenue for the period which DIAL seeking waiver by activating the OMDA clause Force-majeure.	No such Arbitration award passed by the Arbitral Tribunal against AAI for Rs.2300 crores is available in Joint Venture Cell (JVC) of AAI.
