
Reference may kindly be made to your on-line RTI request # AAOIN/R/E/24/01051 dated 20.04.2024, for providing information under RTI Act, 2005.

The information sought by you and reply thereof is as under:

Sl. #	Information Sought	Reply
1	Provide the information detail of the FIR No. 424/2011 dated 22.09.2011 u/s 409 IPC. PS IGI Airport.	The information sought is not maintained in the Joint Venture Cell of Airports Authority of India. Further, it is stated that the information sought by you pertains to more than one (1) Public Authorities, i.e., Delhi Police and Air India, which are separate public authorities. As per Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training's Office Memorandum # 10/2/2008-IR dated June 12, 2008, in case the information sought pertains to more than one other public authorities, the applicant should make separate applications to the concerned public authorities for obtaining information from them. It has also been stated in the said memorandum that, inter-alia, in case information sought concerns a public authority under any State Government or the Union Territory Administration, the applicant may seek information from the concerned State Government / UT Administration.
2	Provide detail of the FIR No.424/2011 dated 22.09.2011 u/s 409 IPC, PS IGI Airport. Who filled the FIR and against who is the FIR and what is the final report of the FIR. Provide the the copy of all.	
3	Provide the information that whether the theft items was found or not if no then why the case not considered seriously and handed over to CBI or other higher investigation department.	
4	Provide the information that is that allow to do professional/full time course like LLB by any government employee if yes then what is the formalities to follow by the employee.	
5	Provide the information that Gyan Chand Garg S/o Lt. Pyare Lal r/o A-71 Shastri Nagar was the employee at Air India (when it was under Govt.) had taken any permission and leave to do LLB during his duty. If yes provide the copy of permission letter.	
6	Provide the information that during the FIR against him u/s 409 IPC was he suspended from the duty or not. If not then provide the reason why he was not suspended as he was the main person of the corruption done in Government Department.	

In case, the applicant is not satisfied with the reply, he/she may file an appeal to the Smt. V. Vidya, Executive Director (PPP/JVC), First Appellate Authority, Airports Authority of India (AAI), Joint Venture Cell, C – Block, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003, under section 19(1) of the RTI Act within the time limit specified in the RTI Act.
