

1.	<p>It is intimated that Airports Authority of India JPNI Airport Patna had invited online GeM tender for Bird and Animal Scaring &amp; Allied Services for 02 years vide GeM Bid No GEM/2024/B/5143501 dated 11 July 2024. It has been observed during scrutiny of the tender documents that AAI has directed that the qualified bidder must have experience regarding Providing Manpower Services for Bird &amp; Animal Scaring Services at the Airports, however AAI has not mentioned the exact value of work done by the bidders during the said work done during the last 03 years which must be incorporated in the tender terms &amp; conditions. The minimum qualifying value of similar nature of work done by the bidder should be mentioned in special terms &amp; conditions. It has been observed that after the bidding and opening of bids, AAI has declared 02 bidders as L1 bidders, however AAI has not checked their qualifications; regarding similar nature of work experience that the said L1 bidders have provided 15 Bird chasers in single contract or 09 Bird Chasers in 02 contracts and 08 Bird Chasers in 03 contracts during last 07 years. Also AAI has not verified their work experience that on which date they have completed the said similar nature of work during last 07 years. It is intimated that as per the terms and conditions of AAI in the tender, the successful bidder must be paid applicable minimum wages to all employees as changed by CLC time to time. However, AAI has not included the clause regarding reimbursement of rate revision as time to time issued by Labour Department, CLC Delhi, which must be included in the terms and conditions of the tender documents. It is also pertinent mention that AAI has not given any purchase preference to MSME bidder which must be given to them.</p>	<p><b>In the enclosed RTI application no information has been sought by the applicant.</b></p>
