	Subject: Request for Continuation of Alliance Air Service on Imphal TO Aizawl TO Imphal Route		

Respected Sir/Madam,

I am writing this application on behalf of several passengers who are currently facing serious inconvenience due to the discontinuation of the Alliance Air flight service on the Imphal TO Aizawl TO Imphal route.

We had travelled to our hometowns in MANIPUR to celebrate the festivals of Diwali and Bhai Dooj with our families. However, due to the sudden suspension of air services on this critical route, we are now unable to return to our respective workplaces. Given the ongoing ethnic crisis in the region, there is no safe or viable alternative mode of transportation available at this time.

The Alliance Air service between Imphal and Aizawl has been a lifeline for many of us, including government employees, students,

professionals, and patients seeking medical treatment. Some of us have to join the office on or before 27th October 2025. Its absence is causing severe distress and disruption to our professional and personal lives.

After all, sudden and very high airfare for other flights to Aizawl (Mizoram), particularly on routes via Guwahati OR Kolkata from Imphal. Over the past few weeks, the cost of air tickets on these routes has increased significantly often doubling or even tripling within a short period. The recent surge in ticket prices has made air travel to the AIZAWL FROM IMPHAL extremely difficult for students, professionals, and working individuals who travel for education, employment, and essential purposes. The current fare levels have become unaffordable, creating severe hardship for those who rely on air connectivity for their livelihood and studies.

Therefore, we earnestly request you to consider the immediate resumption or continuation of the flight services (ALLIANCE AIR) between Imphal and Aizawl in both directions, at least until the situation on the ground improves or alternative arrangements can be made.

We hope for your kind attention and prompt action on this matter of urgent public interest.
