NSCBI Airport has awarded a single Master Concession or F&B facility at NSCBI Airport, Kolkata under which various F&B outlets are operated by the Master Concessionaire. One of the F&B outlet named as Udan Yatri Café has been opened by Master Concessionaire under its concession in December, 2024.
3.	Details of the tendering process, including copies of advertisements, list of bidders, and final allotment details.	Not applicable.
4.	Duration and terms of the lease or license for the cafes operation.	Not applicable.
5.	Guidelines set by AAI regarding pricing of meals, food quality control, and hygiene standards at Udan Yatri Café.	As per contract conditions of Master Concession for F&B facility.
