Please refer your ION No. AAI/ER /RTI/PIO-250/ 2017/23 dated 7th November, 2017 in connection with the RTI application dated 03.11.2017 from Shri Pradip Kumar Das, Sr.Superintendent (MTD), AAI(NAD),Kolkata .

The para wise reply are given below:

- There is no point of nonpayment of OT allowance as the official had submitted the claim for the period 25.12.2016 to 18.02.2017 and accordingly the same were paid. For the rest period as mentioned in the RTI i.e. 19.02.2016(probably the date should be 19.02.2017) to 13.05.2017, no claim have been preferred by the official, hence no payment action.
- All the staff of the discipline who have submitted their claim in proper way , were paid the OT allowance accordingly.
- There is no question of discrimination , as payment are being made on actual claim basis only.
- As the claim was not submitted to RAU,ER so payment was not made.
- It is further reiterated that as no claim was submitted by the official , the question of nonpayment does not arise and nobody has stopped the payment by issuing any such order
