The reply to the queries specific to NSCBI Airport, Kolkata are as under :-

Sl. No.	Information Sought.	Reply.
1.	Kindly inform the details of retiring rooms available at various airports across India viz number of rooms and tariff per hour for the rooms.	The Retiring Room facility at NSCBI Airport, Kolkata is available on a day-use basis exclusively for transit passengers. The facility is extended strictly on first-come, first-served basis, and includes the following accommodation options : <ul style="list-style-type: none"><li>• 23 room with two separate single beds.</li><li>• Separate dormitory accommodations for ladies and gents, with 10 beds each.</li><li>• Tariff [Rs.1120/- per bed (incl. GST), Rs.1680/- per oom (incl. GST) for family (Husband, Wife &amp; kid below 5 yers.) &amp; Dormitory Rs.784/- per bed (incl. GST).</li></ul> Passengers must present valid travel documents indicating transit status at the time of availing the facility. (Transit passengers must produce their next flight within 24 hours.)
2.	Is the rooms rented out on a day basis or on hourly basis.	
3.	The passengers coming to the Airports require the rooms for four to five hours on an average basis, so is there any provision for hourly basis accommodation.	
4.	Details of revenue collected at each airport from the retiring rooms in the last financial year 2024-25.	As per records, total revenue collected R.1,95,12,539.26 (excluding GST) from Retiring Room at NSCBI Airport, Kolkata for FY 2024-25.
