



Subject: RTI – Updation of details of CPIOs / FAA in AAI website.


This has reference to the disclosure made in AAI Website under the heading "Right to Information" wherein information relating to Central Public Information Officers (CPIOs) and First Appellate Authorities (FAAs) of various Directorates are given.

2. In this regard, reference is invited to Para(I) of Member (P&A) letter No.A-60011/23/2005(P&C)/1446(RTI) dated 23.04.2010 which stipulates that **"All Nodal Officers will be responsible in respect of matter falling within their purview for ensuring that the details of all AIOs/APIOs/CPIOs/Appellate Authorities and their areas of work (such as the name, designation, email, jurisdiction of the area of work, office address, telephone numbers, etc. of PIO/CPIO and the Appellate Authority concerned etc.) are updated and uploaded on the website from time to time in respect of matters falling within his/her purview."**

3. In this connection, it is reiterated that CIC has conducted the Transparency Audit of Public Authorities on the basis of data available pertaining to Public Authorities and in accordance with Section 4 of RTI Act, 2005 to take steps to provide as much information suo motu to the public at regular intervals through various means of communication, including internet, so that the public have minimum resort to the use of RTI Act to obtain information with the request to update the information pertaining to your jurisdiction.

4. You are, therefore, requested to please review the same and the list of CPIO and FAA under your control may please be updated and uploaded **with date** on AAI Website as per attached format, through GM (IT), CHQ under intimation to RTI Cell, CHQ. It is also requested that **whenever there is any change in respect of CPIO and FAA due to transfer / promotion / superannuation / change of their work jurisdiction**, appropriate changes may be made in the information of the whole Directorate and the same may be updated and uploaded in AAI website with a copy to RTI Cell, CHQ to avoid delay in forwarding the RTI Applications / Appeals to the concerned CPIO / FAA.
