

3. FINDINGS AND ORDER

3.1 It is stated that the CPIO has provided the information requested in your RTI application dated January 10, 2025. It is also informed that the CPIO has provided the correct information.

3.2 Further, it is noted that the information sought in the RTI application dated January 10, 2025, differs and does not match the contents of the First Appeal dated February 18, 2025; specifically, the information sought in the RTI application is not the same as that sought in the First Appeal.

In view of the above, CPIO has provided the complete information in all respects as requested in RTI. Hence, the 1st Appeal of Sh. Tanish Saini is disposed off accordingly and no action is pending against Jt.GM(HR)/CPIO.
