**1.0 PREAMBLE**

1.1 This Order is made under section 19 to the Right to Information Act, 2005.

**2.0 FACTS**

2.1 The appellant, Shri [REDACTED] Singh, filed an online RTI Request bearing Registration No.AAOIN/R/E/25/01223, RTI Request Registration Date 25.07.2025 under the Right to Information Act, 2005.

2.2 The concerned CPIO/GM (ATM-ATS), AAI received the request by Nodal Officer on 28.07.2025 and disposed of the same on 05.08.2025.

2.3 The appellant has filed the online RTI Appeal bearing Registration No.AAOIN/A/E/25/00222, RTI Appeal Received Date 03.09.2025 stating that, "Provided Incomplete, Misleading or False Information".

**INFORMATION SOUGHT**

Madam/Sir, I had filed RTI applications numbered AAOIN/R/E/25/00615 and AAOIN/R/E/25/00615/1 with AAI seeking to know whether ATM NOC to FTOs had been granted by AAI on the basis of MoD /IAF NOC or without MoD/IAF NOC – copies of the applications and AAI's responses are attached for ease of reference. Please note that the information provided in Annexure-01 of AAI's response to application number AAOIN/R/E/25/00615 does not cover the FTOs listed in serial numbers 01 to 11 of Annexure-01 of AAI's response to application number AAOIN/R/E/25/00615/1. The FTOs listed in serial numbers 01 to 11 of Annexure-01 of AAI's response to RTI Application number AAOIN/R/E/25/00615/1 are listed below, please inform whether AAI's ATM NOC for the following FTOs has been issued based on MoD/IAF NOC or whether it has been issued without MoD/IAF NOC: 1. Flytech Aviation Ltd., Nadirgul, Hyderabad 2. Wings Aviation Pvt. Ltd., Begumpet, Hyderabad 3. Orient Flight Pvt. Ltd., Mysuru 4. NFTI, Gondia 5. Garg Aviation, Kanpur 6. Patiala Aviation Club, Amritsar 7. Jharkhand Flying Club, Ranchi 8. Telangana State Aviation Academy, Begumpet, Hyderabad 9. MP Flying Club, Indore 10. MP Flying Club, Bhopal 11. Gujarat Flying Club, Vadodara

**INFORMATION/REPLY PROVIDED**

MoD clearance is not required for issuing ATM NOC for FTOs which do not operate from/within defence airfields/airspace. None of the FTOs except Garg Aviation, Kanpur mentioned in query are located within/operate from defence airfield/airspace.

3.0 **FINDINGS/ORDER**

3.1 I have carefully examined the case. I fully agree and satisfied with the information provided by CPIO/GM (ATM-ATS), Airports Authority of India. No recorded information prior to 2018, is available with Directorate of Airspace Management, Airports Authority of India, Corporate Headquarters, New Delhi.
