

2.	Provide a copy of my OMR answer sheet/response sheet and the final answer key.	The answer sheet has already been provided to the appeared candidates through their registered E-mail ID by conducting Agency.
3.	Clarify why Eastern Region results were published only with roll numbers of qualified candidates, whereas Western Region results for the same exam published marks of all candidates.	The information sought for is in the form of clarification from a Public Authority, which does not fall under the ambit of definition of information under Section2(f) of the RTIact,2005.
4.	Provide the selection criteria and cut of marks for the said examination in Eastern Region.	Follow career dashboard and advertisement No.ER/01/2024 on Airports Authority of India website www.aai.aero . [https://www.aai.aero/en/careers/recruitment]
5.	Inform whether there is any policy/guideline that prevents disclosure of marks for non-qualified candidates, if yes, provide a copy of the same.	There is no such recorded information.
