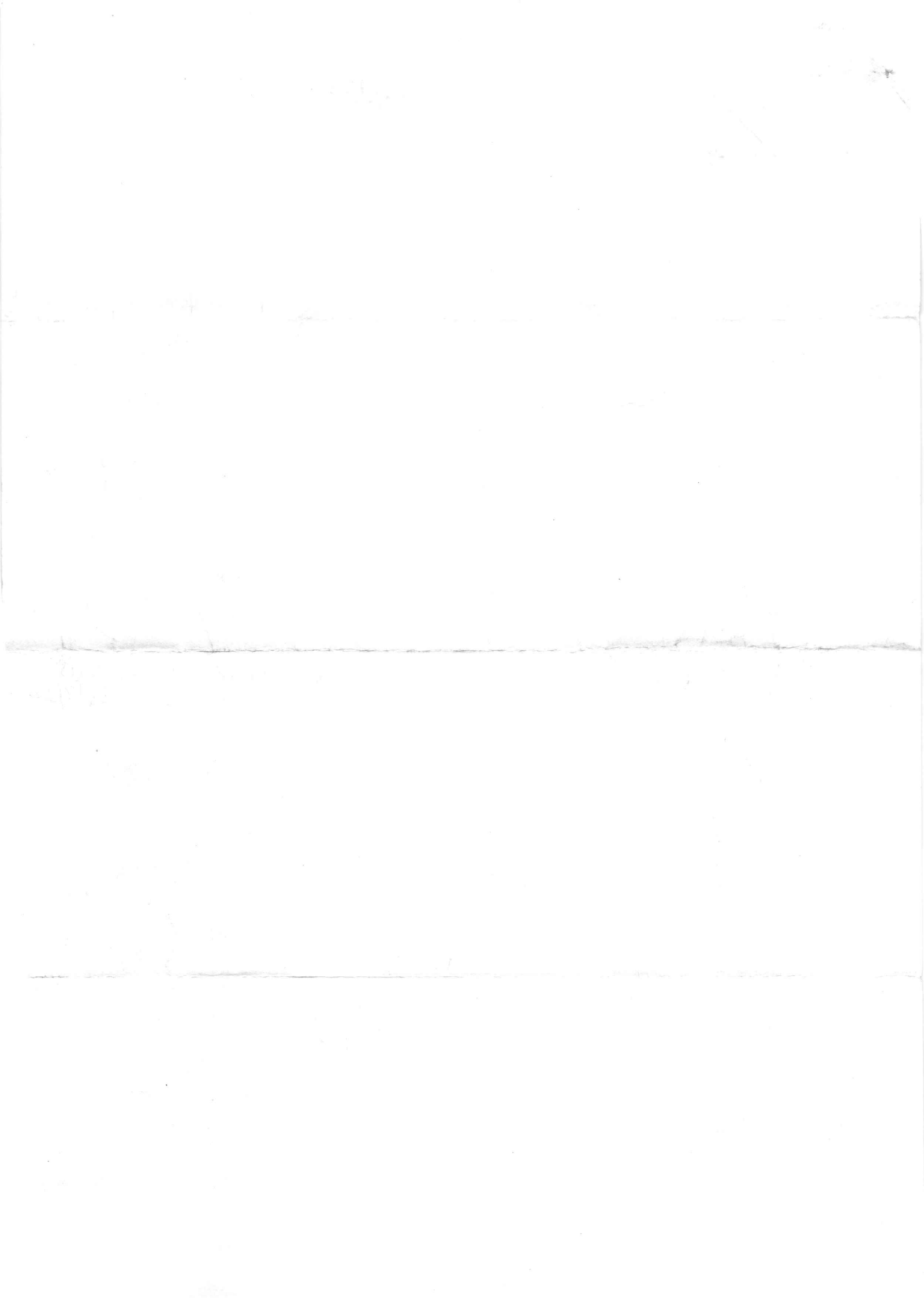

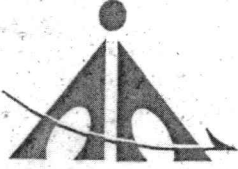



1.0 Preamble:

- 1.1 This order is made under Section-19 of the Right to Information Act 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, August Kranti Bhavan, Bhikaji Cama Place, New Delhi – 110 066.
- 1.3 The appeal may be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 Brief facts of the Appeal:

2.1 Shri Samar Nath Das, 159, SK Sarani Kalabagan, Adarsha Nagar, PO – Nimta, Kolkata-700049, West Bengal made an RTI application dated 24.06.2022 to Smt. Amita Verma, CPIO, Dy. CVO(I), Department of Vigilance, Airports Authority of India, Rajiv Gandhi Bhawan, New Delhi-110003. This application was transferred to NSCBI Airport, Kolkata vide their letter dated 01.07.2022 (received on 04.07.2022) seeking information regarding fatal incident of death of CISF Constable Shri G.C. Singh under RTI Act 2005 & subsequent inquiry against two officials of AAI. The query raised vide the RTI application and reply furnished by the PIO, NSCBI Airport, Kolkata is reproduced hereunder:

3.0 The applicant has now preferred an Appeal before the First Appellate Authority vide letter dated 26.09.2022 stating that *"Since I am not satisfied with reply (see annx-B), hence it is an appeal to your good office to provide the same as enclosed (see annx-A) to the undersigned at an early date."*

4.0 **Findings / Order:**

The undersigned has perused the RTI application dated 24.06.2022 filled by the Applicant and the reply furnished by the PIO vide letter dated 05.09.2022.

4.1 The RTI application was transferred from AAI CHQ on 01.07.2022 which was received by PIO, AAI, NSCBI Airport, Kolkata on 04.07.2022 and as the query pertain to death of CISF Constable & subsequent inquiry against 02 nos AAI officials, the same was checked/verified from HR Department and then transferred to CISF Unit, Kolkata Airport by PIO, AAI, NSCBI Airport, Kolkata vide letter dated 25.07.2022 (with a copy marked to the RTI Applicant) requesting CISF Unit, Kolkata Airport to furnish reply directly to the Applicant under intimation to PIO, AAI NSCBI Airport, Kolkata.


4.2 However, CISF Unit, NSCBI Airport, Kolkata furnished the information to PIO, AAI, NSCBI Airport, Kolkata (instead of directly replying to the Applicant) vide letter dated 11.08.2022 (received on 17.08.2022). Accordingly, PIO, AAI, NSCBI Airport, Kolkata forwarded this reply to the Applicant vide letter dated 05.09.2022.

4.3 The Applicant's Appeal seeks certain information regarding an incident occurred at NSCBI Airport 07 (seven) years back i.e. on 30.07.2015 resulting in death of CISF Constable and based on a presumption that an inquiry was held against two officials of AAI in respect of this incident. The Queries are in the nature of enquiry/inquisition and thus cannot be construed as "information" as defined under section 2(f) of the RTI Act.

C. Prasad

4.4 The Applicant's right extends only to seeking information as defined in Section-2(f) of the RTI Act, 2005 either by pinpointing the file, document, paper or records, etc. or by mentioning the type of information as may be available with the office. Hence, the PIO, AAI, NSCBI Airport, Kolkata has taken the right stand in dealing with the application dated 24.06.2022.

4.5 In view of above, Appellant's appeal dated 26.09.2022 stands disposed.
